Women's Legal Services in Tasmania

Women's Legal Service Tasmania

Women's Legal Service Tasmania is a free statewide community legal service, with offices in Hobart, Burnie and Launceston. It offers:

- a telephone advice line where women across Tasmania can get confidential and free legal advice and referral on all legal matters including family law, family violence, civil and criminal law, estate and property law from highly skilled legal staff
- at times, casework for clients throughout Tasmania who need representation with their legal matters
- community legal education sessions and workshops and publications.

Sexual Assault

Tasmania Police applies a pro-intervention policy in relation to family violence and participates in the Safe at Home* initiative which aims to enable adult and child victims to remain in or quickly return to their own home in safety wherever possible.

To report a non-urgent incident of family violence, call the Tasmania Police Assistance Line on **131 444** or attend your local police station to make a report.

People with hearing impairments can call TTY 106.

Tasmania Victims Services

Sexual Assault Support

Crisis support, counselling and support with forensic medical examination is offered in the South by the Sexual Assault Support Service (SASS) and in the North and North West by Laurel House. The service is free, confidential and for people of all ages who have been affected by any form of sexual violence. Support is also available to family members, carers, friends of survivors and professionals working with people affected by sexual harm.

Counselling and support are available Monday to Friday 9am to 5pm. Crisis Support is available 24/7 at 1800 MYSUPPORT (1800 697 877). Crisis support includes support to report to Police or to have a forensic medical examination.

SASS also offers:

- services to anyone considering applying to, or applying to, the National Redress Scheme for people who have experienced institutional child sexual abuse.
- assessment and therapeutic intervention program for children and young people (aged 17 years and under) who are displaying harmful sexual behaviour. Email: hsbprogram@sass.org.au
